

Please refer to this Ministry's letter dated 31.10.2017, wherein permission was granted to Aarihant Homoeopathic Medical College & Research Institute, Bhoyan Rathod, Opp. Iffco, Adalaj - Sertha Road, Gandhinagar - 382420, Gujarat for taking admission in 1st BHMS course for the academic year 2017-18, with intake capacity of 100 seats, under the provisions of Section 12A of the HCC Act, 1973 subject to fulfilment of certain conditions. In this regard CCH has conducted an inspection to the college on 18.6.2018 for the Academic Year 2018-19 and submitted the inspection report and recommendation to this Ministry.

2. In this regard, I am directed to say that after careful consideration of the inspection report and recommendation of the CCH in terms of the provisions of the HCC Act 1973, relevant regulations of the CCH, permission of the Central Government is hereby granted to Aarihant Homoeopathic Medical College & Research Institute, Bhoyan Rathod, Opp. Iffco, Adalaj - Sertha Road, Gandhinagar - 382420, Gujarat for taking admission in 1st BHMS course with 100 seats and continue admission in 2nd BHMS course for the Academic Session 2018-19 under Section 12A of the HCC Act, 1973.

3. The college administration will ensure that sufficient qualified teaching faculty, non-teaching staff, hospital staff and other requirements as per the provisions of HCC (MSR),2013, Regulations are in position before the admission of the students in the above mentioned course is made, under intimation to the Central Government and CCH for the academic session 2018-19 subject to condition that the college shall fulfill the following requirements by 31^{s1} December, 2018 which will be verified for granting permission from the academic session 2019-20.

i. All the Minimum Standard Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Homoeopathy Central Council (Minimum Standards Requirement of Homoeopathic Colleges and attached Hospitals) Regulations 2013" by 31st December 2018 to get permission for a period not exceeding five years. Failing which, all the existing colleges, which are not able to achieve full compliance of the requirement as specified in these regulations by the 31st December, 2018, shall be denied permission from academic year



2019-20 onwards and action as envisaged under section 19 of the Act shall be initiated against all such colleges apart from rejection of their applications under sections 12A, which have been under consideration by way of conditional permissions or denials"; and

ii. All the requirements under the provisions of the HCC Act, 1973 and relevant Regulations made thereunder should be fulfilled *in toto*.

4. The college has to develop the requisite infrastructure for 3rd and 4th BHMS courses well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.

5. The college administration may take up the matter for recognition of the qualification under section 13(1) of the HCC Act, 1973 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course
