Sir/Madam,

Medical Assessment and Rating Board for Homoeopathy has received an application from Aarihant Homoeopathic Medical College & Research Institute, at Bhoya Rathod, Opp. Iffco Adalaj-Sertha Road, Gandhinagar-382420 for Opening new or higher course of study or training for PG Course with intake capacity of 28 seats in 04 Subjects namely Homoeopathic Materia Medica with 07 seats, Organon of Medicine with 07 seats, Repertory and Case taking with 07 seats, Practice of medicine with 07 seats for academic year 2025-26.

A Letter of Intent (LoI) has already been issued to the college for PG Course with intake capacity of 28 seats in 04 Subjects namely Homoeopathic Materia Medica with 07 seats, Organon of Medicine with 07 seats, Repertory and Case taking with 07 seats, Practice of medicine with 07 seats for academic year 2025-26 on 20.05.2025 on the basis of inspection report submitted by the two inspectors. The inspection was conducted on hybrid mode (02 inspectors on site, 01 inspector from MARBH office on virtual mode) on 19.06.2025, and virtual visitation on 26.06.2025, followed by Physical Hearing on 21.07.2025.

College has submitted bank guarantee on 09/06/2025.

In view of the bank guarantee submitted by the college, MARBH has decided to issue Permission to Aarihant Homoeopathic Medical College & Research Institute, At Bhoya Rathod, Opp. Iffco Adalaj-Sertha Road, Gandhinagar-382420 for Opening new or higher course of study or training for PG Course with intake capacity of 24 seats in 04 Subjects namely Homoeopathic Materia Medica with 06 seats, Organon of Medicine with 06 seats, Repertory and Case taking with 06 seats and Practice of medicine with 06 seats for academic year 2025-26 since college can apply for a maximum of 06 seats in any post graduate department while making a new application (Regulation 4 of The National Commission for Homoeopathy (Homoeopathy Postgraduate Degree Course- Doctor of Medicine in Homoeopathy) Amendment Regulation, 2025 sub-section (a) (3), for the words "seven seats", the words "six seats" shall be substituted).

All admissions shall be made from NEET/ AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 100 UG Seats and 24 PG seats shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.
