Sir,

Aarihant Homoeopathic Medical College and Research Institute, Bhoyan Rathod, Opp. IFFCO, Adalaj Sertha Highway, District-Gandhinagar, Gujarat-382420 for admission in BHMS undergraduate course with Intake Capacity of 100 Seats for the Session 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under NCH Act 2020, as per section 29 and subsection (3) of the Act.

As per the observations made by MARB, following information are provided for immediate rectification of the shortfalls. College shall fulfil all functional requirements as per the Minimum Standard Requirements as mentioned below:-

- **Teaching faculty: -**
 - a) 09 Consultants of Modern Medicine and 12 guest faculty shall be provided with name in attendance and Acquittance role.
- **Hospital facilities: -**
 - a) IPD/OPD Case sheets shall be maintained with demographic details of patients, diagnosis as per ICD 11 criteria, complete case history analysis and evaluation and repertorisation and made available in the Medical Record Room for academic purpose of students and for follow-up attendance of the patients.
 - b) Copy of Case records shall be submitted against the direction issued from MARB. IPD and OPD case records (copy of one OP and one IP case of 1st and last day of every month) shall be submitted for verification.

Considering the above observations, and facilities available, MARB has decided to issue **Conditional Permission to Aarihant Homoeopathic Medical College and Research Institute, Bhoyan Rathod, Opp. IFFCO, Adalaj Sertha Highway, District-Gandhinagar, Gujarat-382420 for admission in BHMS for undergraduate course with Intake Capacity of 100 Seats for the session 2024-25.**

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

All admissions shall be made by NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if the college is found deficient in compliance to MSR 2013, anytime during the academic year.
