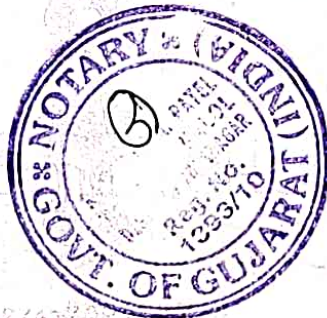
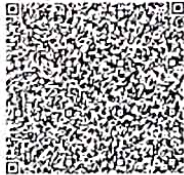

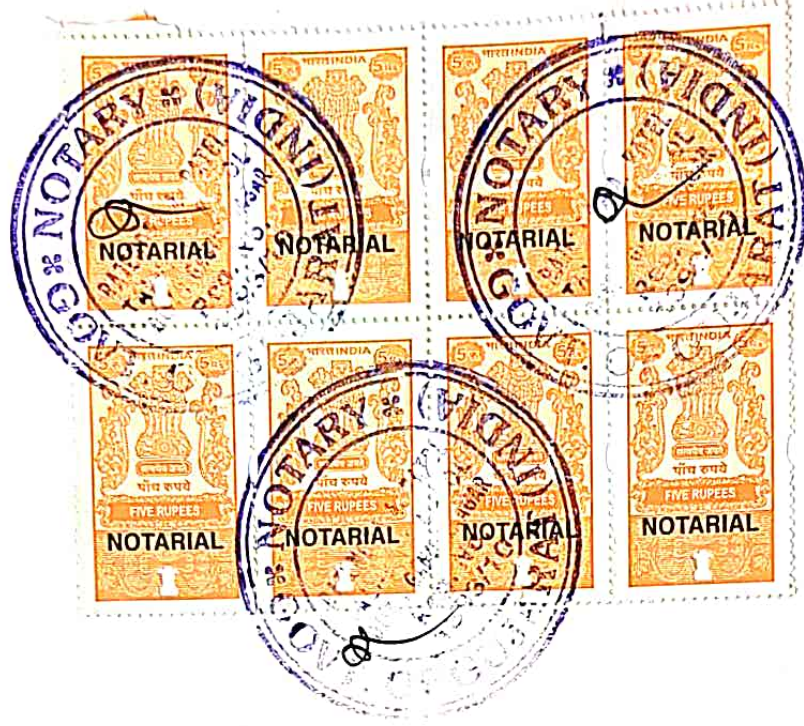

**Represented by: (hereinafter referred to as the "Second Party", which expression shall, unless repugnant to the meaning or context hereof, be deemed to include its successors and permitted assigns); ON THE SECOND PART.**

**Article 01: Participation and Coordination**

The partnership shall initially establish between the following:

1. Swarnnim Startup & Innovation University, Vallabh Vidyanagar
2. Samuel Hahnemann Academy for Homeopathy LLP, Anand

The registrar shall be the representative from Swarnnim Startup & Innovation University, and Dr. Krutik Shah shall be the representative from Samuel Hahnemann Academy for Homeopathy,

Anand. The participants and representatives may change time to time as decided by competent authority of the respective institutions.

#### **Article 02: Purpose of MOU**

##### **a. Exchange of information and sharing of experience:**

Recognized as a dry and overlooked subject in the field of homeopathy, the MOU in the subject of Organon of Medicine and Homeopathic Philosophy aims to raise awareness about its significance among homeopathic students. The goal is to demonstrate its intriguing clinical aspects and enable students to achieve success in their homeopathic practice.

A comprehensive Foundation Course in Samuel Hahnemann's Applied Homeopathy will be offered under this MoU.

Representatives of both parties shall arrange joint meetings at regular intervals to exchange experiences in field of homeopathic education and practice, or research and to prepare proposals for joint projects.

The curriculum for the Foundation Course in Samuel Hahnemann's Applied Homeopathy will be designed for all years of graduation and post-graduation. It will be as per the educational curriculum provided by the National Commission of Homeopathy, Government of India.

**b. Collaboration, Cooperation and Interaction:** The parties recognize the benefits to be derived from increased collaboration, cooperation and interaction for the purpose of promotion and understanding of high performance in the field of Homeopathy, and organizing various programs for students of Swarnim Startup & Innovation University.

This MOU is looking for organizing certificate program / training / workshop / conference / seminars / conclave collaboratively with a view to cater students' overall development.

- **Interactive Q – A session and Case Discussion LIVE with Dr. Krutik Shah: Approx. 2 hours every year**
  - **Duration of the Course Access:**
    - After signing up on the platform at <https://university.samuelhahnemann.org> - An account will be activated within a maximum of 72 hours. University students pursuing their respective year of graduation or post-graduation will receive the appropriate course modules in their account.
    - All the topics mentioned in the curriculum are highly practical and carefully designed. Therefore, random selection and video skipping are not allowed. The next video will start playing automatically once the current one is about to finish.
    - The curriculum for the Foundation Course in Samuel Hahnemann's Applied Homeopathy will be designed for university students and will be academically synchronized with the National Commission of Homeopathy (NCH), Government of India:
      - Only for the existing academic year from 2024 to 2025:
        - The initial period of access for university students studying either B.H.M.S. or M.D. will be from the date of their course registration until their upcoming annual university exam.
        - They must complete all the course modules from previous academic years before their annual university exam in order to continue into the next academic year.
      - For all the upcoming academic years 2025 to 2029:



- The course modules from previous academic years will be disabled, and the new course module for the current academic year will be activated.
- Students will have access to the course for 10 months from the beginning of the academic year.

Upon completion of each prescribed course module, a badge of module completion will be automatically generated in the student's account as an achievement. Upon earning a total of 4 badges, the student will be recognized as having completed the Foundation Course in Samuel Hahnemann's Applied Homeopathy by Samuel Hahnemann's Academy for Homeopathy LLP.

- **Course Access to the Coordinator appointed by the University:**

- The E-Learning Platform allows for access and monitoring of the digital activity of all students using the platform.
- The university-appointed coordinator will have online access to the admin section for the "Foundation Course in Samuel Hahnemann's Applied Homeopathy" (<https://university.samuelhahnemann.org/admin>) to monitor university students' digital activity and learning during their participation in the course.

- **Hibernation of the course:**

- The Memorandum of Understanding (MoU) aims to ensure high-quality education with an emphasis on self-discipline. If a student is inactive in their learning for more than four months without prior notice, whether at the start of the course or during its duration, their account will be temporarily suspended.
- To request the reactivation of their account, the student must send an email from their registered email address, mentioning their university ID. Upon receipt of this email, their account will be reactivated.

- **The Final Course Completion E-Certificate:**



- Samuel Hahnemann's Academy for Homeopathy LLP will verify the completion badges for all 4 modules of the university students and will inform the university-appointed coordinator about the completion of their " Foundation Course in Samuel Hahnemann's Applied Homeopathy."
- The e-certificate for the final course competition, "Foundation Course in Samuel Hahnemann's Applied Homeopathy," will only be Issued to students who have earned a total of 4 badges and have been approved by the university-appointed coordinator. The course completion e-certificate will include the names and logos of both institutes, as well as student details.

- **Feedback and assessment system:**

The internal assessment system will ensure that each student receives consistent education. Each participant will be asked to provide feedback on their learning following the completion of the Foundation Course In Samuel Hahnemann's Applied Homeopathy.

- **Benefits:**

Foundation Course in Samuel Hahnemann's Applied Homeopathy is a skill based program which will empower students' clinical skills, homeopathic medical skills and case management skills to uplift their homeopathic practice.

- **Research:**

Minor or major research projects with reference to interdisciplinary or multidisciplinary or transdisciplinary could be done in collaboration; where in the available resources from both the institution can be utilized. The results of research findings dissemination will be decided by both the parties mutually. Joint publications with mutual consent also will be considered. They will also explore the possibilities of research in homeopathy for distance and computer-based learning.

- d. **Foster hybrid learning:**

The parties will explore the possibility of formulating a hybrid education program based on the expertise available in both institutions as mentioned,

**Article 03: Financing**

This agreement will be *non-financial from both the parties.*



In course of time, if it is mutually agreed by both the parties, the remuneration could be paid for rendering the services by both the institutions.

**Article 04: Parties intend to**

- I. Strengthen the ties between Swarnim Startup & Innovation University, Vallabh Vidyanagar and Samuel Hahnemann Academy for Homeopathy LLP, Anand to make collaborative efforts in the field of education and developmental sectors.
- II. Engage students in internships / clinical practice / field works and may support for students' employability.
- III. For sharing the field expertise by both the parties as resource persons in each other's institutions or in the sister-concerned or could be association with other institutions.

**Article 05: Mode of Operation**

- Both the parties will provide necessary support for effective implementation of the MOU within the institutional rules and procedures.
- This MOU shall be effective from the date it is signed by both the parties.

**Article 06: Validity**

This MOU is valid for an initial period of 05 years and becomes effective from the date it is signed by the partners. The period may be extended by mutual consent. In case one party wishes to cancel this MOU, it may be done so only by a prior written information of at least three months.
