BhoyanRathod, Opp.IFFCO (ONGC WSS), Adalaj-Kalol Highway, Dist Gandhinagar-382420, Managed By Shri Gaya Prasad Jain Charitable Trust Ahmedabad herein after referred to as the party of the First Part (This expression shall meanand include its present office bearers and executors in the interest of educators, administrators and assignees) and TAN Hospital and ICU, Kalol, Located at Kalol, here in after referred to as the party of the Second Part. 
