This agreement is entered in to at Bhoyan, Rathod between the Aarihant Homoeopathic Medical College and Research Institute At. Bhoyan Rathod, Opp. IFFCO (ONGC WSS), Adalaj-Kalol Highway, Dist Gandhinagar-382420, Managed By Shri Gaya Prasad Jain Charitable Trust Ahmedabad herein after referred to as the party of the First Part (This expression shall mean and include its present office bearers and executors in the interest of educators, administrators and assignees) and TAN Hospital and ICU, Kalol, Located at Kalol, here in after referred to as the party of the Second Part. 3. Duration and Termination


- This MoU will be valid for a period of 5 years from the date of signing

4. Confidentiality


Both parties agree to maintain the confidentiality of any proprietary or patient information shared under this MoU

Any disputes arising out of this MoU shall be resolved amicably. If unresolved, they will be subject to the jurisdiction of the courts at [City, State]

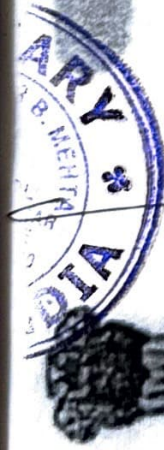
