**Sub: Application for Letter of permission for continuing BHMS course with intake capacity of 100 seats and Opening new or higher course of study or training of Aarihant Homoeopathic Medical College & Research Institute, At Bhoya Rathod, Opp. Iffco Adalaj-Sertha Road, Gandhinagar-382420 for PG Course with intake capacity of 28 seats in 04 Subjects namely Homoeopathic Materia Medica-07 seats, Organon of Medicine-07 seats, Repertory and Case taking-07 seats, Practice of medicine-07 seats for Academic year 2025-26 under section 28 and 29 of NCH Act 2020-reg.**

Sir/Madam,

Medical Assessment and Rating Board for Homoeopathy has received an application from Aarihant Homoeopathic Medical College & Research Institute, at Bhoya Rathod, Opp. Iffco Adalaj-Sertha Road, Gandhinagar-382420 for continuing BHMS course with intake capacity of 100 seats and Opening new or higher course of study or training for PG Course with intake capacity of 28 seats in 04 Subjects namely Homoeopathic Materia Medica-07 seats, Organon of Medicine-07 seats, Repertory and Case taking-07 seats, Practice of medicine-07 seats for academic year 2025-26.

The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 29.04.2025 and 30.04.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls:

- One Associate Professor is *not available* in Department of Physiology and Biochemistry.
- One Professor is not available in Department of Community Medicine, Research Methodology and Biostatistics.
- One Professor is not available in Department of Research Methodology and Biostatistics.
- A separate visiting faculty for teaching fundamentals of psychology in Department of Organon of Medicine is not available.
- One male yoga instructor is not available in Department of Yoga and Health Promotion.
- Salary of Teaching and Non-teaching staff is not as per MES, 2024.

As evident from the above statement, a total number of two teachers are deficient against the requirement of 40+1 for 100 seats UG college (As specified in MES,2024). Pursuant to F.No. :3-2/MARBH/NCH/2025-26/162-169 dtd. 16/04/2025 issued by MARBH, a college can avail 10% relaxation against the required number of teachers for Academic Year 2025-26 only. However, such relaxed number of teachers may be appointed at the earliest for smooth conduct of course.



Considering the above observations during inspection, MARBH has decided to issue **Conditional Permission to Aarihant Homoeopathic Medical College & Research Institute, At Bhoya Rathod, Opp. Iffco Adalaj-Sertha Road, Gandhinagar-382420 for continuing BHMS course with intake capacity of 100 seats for the academic year 2025-26** on the basis of following conditions: -

- i. College should appoint a separate visiting faculty for teaching fundamentals of psychology in Department of Organon of Medicine.
- ii. College should appoint One male yoga instructor in Department of Yoga and Health Promotion.
- iii. The salary of the staff should be as per the criteria mentioned in MES,2024.

Furthermore, MARBH has decided to issue **Letter of Intent (LoI) for PG Course with intake capacity of 28 seats in 04 Subjects namely Homoeopathic Materia Medica-07 seats, Organon of Medicine-07 seats, Repertory and Case taking-07 seats, Practice of medicine-07 seats for academic year 2025-26**, subject to the condition that following shortfalls shall be fulfilled before the inspection by Medical Assessment and Rating Board for issuance of Letter of Permission (LoP) for PG Course for the academic session 2025 -26, failing which Letter of Permission (LoP) shall not be issued and Letter of Intent (LoI) issued shall deemed to be withdrawn for PG Course:

- i. College should appoint One Professor in Department of Research Methodology and Biostatistics.
- ii. Appointment letters of PG Teaching staff with Degree certificates, experience letters and other relevant documents.
- iii. University approved Guide list for PG Course.
- iv. The salary of the staff should be as per the criteria mentioned in MES,2024.


The applicant is also required to submit the requisite performance bank guarantee of **Rupees One Crore, forty lakhs only (Rs. 1,40,00,000)** within 15 days, valid for a period of 3 years, in favor of National Commission for Homoeopathy, New Delhi notified under Regulations namely the *'Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2011 (as amended up to 2018)*.

The college administration needs to ensure that no student is admitted against the above-mentioned PG course till the formal permission by issuing Letter of Permission (LoP) of the Medical Assessment and Rating Board for Homoeopathy is granted. In the event of failure to comply with or satisfy the conditions of the Letter of Intent, the LoI would automatically lapse and be treated cancelled without further information to the applicant college.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats course shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.
