F.No. 3-34/2023/NCH/HEB/C.C/Pt.I. —In exercise of the powers conferred by sub-section (1) and clauses (h), (i), (q), (s) and (t) of sub-section (2) of section 55 of the National Commission for Homoeopathy Act, 2020 (15 of 2020), the National Commission for Homoeopathy hereby makes the following regulations to amend the National Commission for Homoeopathy (Homoeopathy Graduate Degree Course — Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S). Regulations- 2022, namely:-

- Short title and commencement. –(1) These regulations may be called the National Commission for Homoeopathy (Homoeopathy Graduate Degree Course – Bachelor of Homoeopathic Medicine and Surgery (B.H.M.S.) Amendment Regulations, 2024.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
