With reference to the subject cited above, this is to inform that the National Testing Agency (NTA), a designated agency of examination for National Commission for Homoeopathy (NCH) has issued public notice for inviting online applications for NTET: 2024, as per the guidelines issued by the NCH.

- 2. Accordingly, all the concerned stakeholders are hereby informed that from the date of announcement of NTET examination by NTA i.e. 24<sup>th</sup> September, 2024, candidate(s) qualifying the said examination shall only be eligible for appointment as Teachers in any Homoeopathic college regulated by NCH.
- 3. Candidates intending to appear for the NTET must ensure that they meet the eligibility criteria as outlined at Para 5 of the NTET guidelines uploaded by the Commission on its website vide its letter no. 3-146/2024/NCH/HEB/NTET dated 21<sup>st</sup> August, 2024.
