Chief Guests

Resource Person

DAY 1

Session 1

Dr. Munir Ahmed Sir, Director of RGUHS Academic & Administrative Training Institute, delivered an engaging session on implementing Homoeopathic Pharmacy and Clinical subjects in line with the CBME syllabus. He emphasized skill development, competency building, curriculum planning, and educational objectives. The session also highlighted tools for effective teaching, lesson planning, group activities for students, and the OSPT model in pharmacy, making it highly interactive and insightful.

Session 2

Dr. Shital Shah Ma'am, Consultant Homoeopath, conducted a session on teaching drug sources from plant, mineral, and animal origins. She highlighted Dr. Hahnemann's perspective, innovative teaching methods, thematic and visual learning, field visits, and experiential approaches. She also emphasized the unique qualities of each source in relation to Materia Medica, aiding better understanding and identification.

DAY 2

Session 1

Dr. Vivek Gupta, HoD, Pharmacy, Government Homoeopathic Medical College, Gujarat an eminent expert in pharmaceutical sciences. His today's session was on Recent Advances in Homoeopathic Pharmacy. He delivered a series of insightful lectures covering a wide spectrum of subjects ranging from modern drug delivery techniques to specialized branches of homoeopathy.

His sessions highlighted key topics such as Solubility Enhancement Approaches for Poorly Soluble Drugs, Homoeopathic Pathogenetic Trials, Organ-Specific Deposition and Pharmacokinetics of Small Molecules and Peptides, Human Homoeopathy, Agro Homoeopathy, Veterinary Homoeopathy, and Pharmacovigilance in Homoeopathy.

In addition to these lectures, he also conducted an engaging group activity designed to demonstrate innovative teaching methodologies in alignment with the CBDC curriculum, which was highly appreciated by participants.





Session 2

Insightful Session on Action of Medicine at different level/ Pharmacodynamic by an esteemed resource person **Dr Harsh Trivedi Sir**, Professor Aarihant School of Pharmacy, SSIU, focusing on the core concepts of pharmacodynamics and their relevance to homoeopathy. The lecture offered deep insights into the principles of drug action and the mechanisms through which drugs exert their effects, bridging the gap between modern pharmacological understanding and homoeopathic perspectives.

The session emphasized the drug–receptor theory, explaining how drugs interact with specific receptors to initiate biological responses. The expert also highlighted the phenomena of drug interactions, underlining their clinical significance and the importance of understanding synergistic as well as antagonistic effects in therapeutic practice.

Special attention was given to the concepts of desensitization and tachyphylaxis, explaining how repeated drug administration may reduce responsiveness, a principle that finds parallel relevance in the selection and repetition of homoeopathic remedies.

By drawing comparisons between pharmacological principles and homoeopathic philosophy, the session not only broadened the participants' scientific outlook but also encouraged critical thinking and research-oriented learning.

The lecture was highly appreciated by participants for its clarity, depth, and practical orientation, making it a memorable academic experience.

DAY 3

Session 1

The session was conducted by the eminent resource person **Dr. Kaushik Debdas Sir**, Head of the Department of Homoeopathic Pharmacy, Government Homoeopathic Medical College, Gujarat. He delivered an insightful talk on “How to Teach Homoeopathic Pharmacy – Effective Teaching Strategies.”

He emphasized the current status of homoeopathic pharmacy, the responsibilities and attitude of educators, and the importance of understanding learners while guiding them towards future prospects in the field. He also highlighted innovative methods for creating engaging presentations and shared activity-based approaches to make learning more enjoyable and memorable for students.

Session 2

Prof. Dr. Hina Patel Ma'am, Principal, Bhargava Homoeopathic Medical College and Research Institute, presented a session on “Method of Selection and Preservation of Drug Substances.” She emphasized quality control, proper raw material sourcing, and maintaining suitable storage conditions to ensure the efficacy of homoeopathic medicines. She also highlighted the importance of choosing appropriate containers, adhering to the Homoeopathic Pharmacopoeia of India, and conducting regular quality checks. Proper labeling and documentation, she noted, are essential for preserving potency, safety, and consistency.



A interesting group activity was conducted discussing horizontal, vertical & spiral integration in study curriculum.

DAY 4

Session 1

Dr. Amar Bodhi Sir, delivered an engaging session on the relationship between Pharmacy, Homoeopathic Materia Medica, Homoeopathic Philosophy, Botany, Chemistry, and Economics. He highlighted the interconnection of these disciplines and their collective role in advancing homoeopathic practice.

The talk covered important aspects such as pharmacognosy, phytomedicines, the role of chemistry in pharmacy ie properties, interactions, and potential effects of substances used, dispensing and patient care, drug design and development, formulation and compounding, role of preservatives as well as trends in the pharmaceutical market. His presentation provided valuable perspective on how scientific and economic principles shape modern homoeopathy.

Session 2

Dr. Shoukath Ali's Sir, session on Homeopathic Pharmacopoeias and other Pharmacopoeias. He delivered an insightful session on Homeopathic Pharmacopoeias, highlighting their definition and significance in the field of medicine. He emphasized the importance of these pharmacopoeias in ensuring uniformity, safety, and reliability of homoeopathic preparations. The session shed light on key aspects, including standards for preparation, quality control, and regulatory compliance, all of which play a vital role in maintaining the efficacy of medicines.

He also provided an overview of various official homeopathic pharmacopoeias recognized globally, such as:

Homoeopathic Pharmacopoeia of India (HPI)

Homoeopathic Pharmacopoeia of the United States (HPUS)

British Homoeopathic Pharmacopoeia (BHP)

German Homoeopathic Pharmacopoeia (GHP)

French Homoeopathic Pharmacopoeia.

This session proved to be highly informative, giving faculties a deeper understanding of the standards that guide homeopathic pharmacy worldwide.

DAY 5

Session 1

Dr. Navin Pawaskar Sir, Director JIMS Homoeopathic Medical College & Hospital, delivered an enlightening session on the Application of Homoeopathic Pharmacy knowledge in clinical practice. He illustrated this through a case of hypertension treated with Veratrum Viride, supported by references to pharmacological studies from various authoritative sources.



He highlighted how the field of pharmacology has evolved and emphasized the vital role it plays as a foundation of Materia Medica. The session further explored the importance of understanding pharmacological aspects in homoeopathy, particularly in guiding the selection of the correct dose for effective treatment.

He also discussed the outcomes achievable through teaching Homoeopathic Pharmacy and methods to ensure these outcomes are met. Additionally, he introduced the concept of decision-support tools, such as clinical assessment and case analysis scores, to aid practitioners in making informed and precise prescriptions.

Session 2

Dr. Valavan Ramachandran Sir, Head of Scientific, Medical & Regulatory Affairs at Schwabe India, delivered an engaging session on the methods of selection and preservation of drug substances. He focused on practical aspects such as maintaining standards, preservation of different sources, storage practices for homoeopathic products, and innovative approaches in selection, standardization, and preservation. A special highlight was his demonstration on the collection and preservation of the Ophidia group through video. The session also included an interactive group discussion, quiz, and activities, which were enthusiastically received by the participants

DAY 6

Session 1

Dr. Divya Taneja Ma'am, Research Officer, Homoeopathy / Scientist-2, CCRH - Delhi, presented her session on Research & homoeopathic pharmacy, stressing on scope of homoeopathic pharmacy, importance of stability studies, clear research requirements, and scientific validation. She explained the need for research to ensure efficacy, safety, and wider global acceptance. Her talk covered comparative potency studies, innovative dosage forms, veterinary applications, and the role of pharmacovigilance in patient safety. She also outlined future research directions focused on innovation, quality assurance, and integrating traditional wisdom with modern science, while engaging participants in thought-provoking research brainstorming activities.

Session 2

Dr. E. S. Rajendran Sir Senior Consultant — Homoeopathy, Mar Sleeva Medicity, Kerala delivered an insightful session on the Current advances in Homoeopathic pharmacy & Research, presenting homoeopathy as a form of nano and quantum medicine. He discussed nanoscience, quantum dots, and explained why homoeopathy qualifies as nano-quantum medicine. The session featured HRTEM images of different drugs in various potencies, along with the discovery of nanoparticles across all potencies and their role in gene regulation, opening new scientific dimensions for homoeopathy.
